#### Launch of the 2018 Ruhama Annual Report



In April, we launched our 2018 Annual report, detailing the support we provided to individuals in prostitution last year - including 122 victims of sex trafficking. The vast majority of those who sought support were women, reflecting the highly gendered nature of the sex trade. The report chronicles 3 decades of our frontline work with some of Ireland's most vulnerable and marginalised women. It also delves into 'The Truth About Prostitution', based on international research and our direct frontline work with those affected.

#### Ruhama attend April CAP congress in Germany



In April, Ruhama attended CAP International's 3rd World Congress in Mainz, Germany entitled 'Prostitution:

Neither Sex Nor Work'. The congress kicked off with a survivor street demonstration in Mainz, calling for an end to commercial sexual exploitation. We heard from many survivors, organisations, health professionals and academics during the congress, ending with an open declarative letter to Chancellor Angela Merkel and the German government, to address the violence of prostitution in Germany.

#### Brussels meeting to tackle trafficking in Europe

Ruhama attended a June meeting of the EU Civil Society Platform against Trafficking in Human Beings in Brussels. Hosted by EU's Anti-Trafficking coordinator, Myria Vassiliou, it brought together **organisations working on trafficking issues**, including Europol, UNODC, Eurojust and the Fundamental Rights Agency. **Serious concerns** were raised about the numbers of women and girls being trafficked for the purpose of sexual exploitation in the EU. A core takeaway was that EU Member States must focus on **deterring demand** and **bringing exploiters to justice**. We also paid a visit to our Brussels Call allies at the European Women's Lobby while over there!





### Finally I Can Be Me

## Astrid's Story

Ruhama offered support to Astrid\* by way of casework, counselling and education and development assistance. This is her story.

I am a lesbian woman. That is something that I don't say too often and only my closest friends know I am gay. In May 2015, Ireland became the first country to legalise same sex marriage through a referendum. You might wonder then why in a country like Ireland, where people actually voted for equal marriage, I still struggle to say the words 'I am a lesbian woman'.

I grew up in a country where it was illegal for me to express my sexuality. Before the vote in Ireland, my country's president even attempted to bring in a law that would see gay people put to death. Sometimes I am angry when I think about my country but mostly I am sad. I worry about people like me, who are still suffering there.

I had a difficult childhood. I was sexually abused by my uncle and his two sons when I was a child, when I had to live with them. My parents didn't care or notice. I was scared and alone. Now, as time has moved on, I think; what kind of people think it's ok to allow grown men to abuse a girl but refuse to accept same sex love? I was only able to escape the situation when I became an adult. I accepted the help of a woman but she said I had to pay her the money back by going into prostitution. I was in prostitution for nearly 4 years.

During that time I continued to suppress my sexuality when men paid for sex with me. I was relieved to escape my uncle's home but the brutality of day to day life in prostitution haunts me to this day. I still struggle to talk about it. After I paid her back I came to Ireland and even though I knew I was gay, I had never been with a woman properly. I still couldn't tell anyone that I was lesbian here, because the people I lived with would condemn me.

Ruhama were part of my journey to finding myself and moving past the sexual abuse I had suffered and the trauma of prostitution as an adult. Their counselling, courses and casework all provided me with a safe space to explore who I was and develop as a person. Once I became more confident, I wanted to explore my sexuality and I started dating. I am happy to report that I have had some embarrassing dating experiences but also some great ones! I have also made lots of friends and I am enjoying being me.

Bridge to Work Employment Programme



Helping women learn hospitality skills and access work opportunities in a supportive environment

#### The Growth of Cafe Culture in Ireland

Walk around Dublin and you cannot help but observe the phenomenal growth of 'cafe culture' in Dublin and Ireland. Despite our love of tea, research shows that a third of Irish consumers buy a coffee outside of the home at least once per day. The growing popularity of the café culture has resulted in a strong demand for skilled Baristas and cafe staff.

To tap into this growing trend, Ruhama have develoed an exciting new initiative called 'The Coffee Academy'.







### What is the Coffee Academy?

It's a specialised work experience programme run under the wider Bridge
To Work Employment Programme. It comprises of five key elements:

Barista Training
Making an espress

Making an espresso, steaming milk, pulling shots, temperature and consistency 02

**Online Training** 

Online Training: Focusing on HACCP 1 + 2 and Allergens

Work Placement
Six weeks 10 hours

Six weeks, 10 hours per week. The participant will learn skills in Customer Service, Teamwork, Till Operations, Serving Coffee and Catering, Safety Procedures and Cleaning 04

From the Bridge To Work coordinator and employer

Participants will work with the Bridge to Work programme coordinator to secure employment

#### Our Key Programme Aims:

To create a bespoke **pathway into employment** within the hospitality sector

To break down existing barriers to employment e.g. a woman's low level of confidence

To facilate women **secure work experience** in a safe supportive environment

#### Support for the participants:

The **programme coordinator** works closely with participants throughout the Academy

Weekly support meetings and phone calls with the coordinator

We provide **financial support** to cover travel and subsistence

Support from coordinator after the Academy to **secure employment**: including CV preparation, job application and interview support

#### Piloting The Coffee Academy and improving

The Coffee Academy was designed based on feedback from Dublin's coffee community and launched as a pilot programme initially with four participants and four employers. The programme coordinator met with cafes to explain the concept and how they could facillate work experience for participants. Employers rotated participants on a weekly basis to train them in different aspects of hospitality, communicated with the programme coordinator and gave feedback and if appropriate – provided a reference at the end of the placement. We are committed to continually improving this model with feedback from participants, employers and the wider community.

### 3rd World Congress against the sexual exploitation of women and girls

After Paris (2014) and New-Delhi (2017), CAP international and its 27 member organisations from 22 countries will hold their 3rd World Congress against the sexual exploitation of women and girls in Mainz.

This Congress is hosted by SOLWODI, German member organisation of CAP intl, Armut und Gesundheit e.V., and organised with the support and participation of the whole abolitionist movement in Germany.

The Congress will be opened by a Survivors' Day on the 2nd of April in the afternoon. An extraordinary group of prostitution survivors from Germany and all over the world will call on German's authorities to fully revisit their harmful public policies on prostitution. An international public conference will then gather, on the 3rd and 4th, 300 participants and 40 speakers from 30 countries, including:

- Survivors of prostitution and trafficking,
- Representatives of domestic, regional and international abolitionist NGOs
- Renowned academics and journalists
- Ministers and Members of Parliaments
- Representatives of Intergovernmental organisations

This public conference will address the realities of prostitution and sexual exploitation in the world, their severe impact on health, and their consequences on sexual violence and gender inequalities. It will also highlight the extremely preoccupying situation in Germany, the "brothel of Europe". With this World Congress, the organizers aim to raise awareness and empathy in order to break the isolation, indifference, exploitation and discrimination faced by hundred of thousands victims of prostitution and trafficking for sexual exploitation.

International and German NGOs will formulate together concrete recommendations to put an end to the exceptionally high level of impunity enjoyed by sexual exploiters and abusers and to create the conditions for prostitution and exploitation-free societies.
